For the purpose of this policy, "zone of the school refers to an address which is routinely serviced by a Hawkins County school bus that delivers students to the school for which you are seeking admission/enrollment". A student may have only one legal residence, and that legal residence will be deemed to be that of the parent/s, legal guardian/s, or person/s with power of attorney for the minor child or children. Students who are enrolled under false or misleading pretense will be subject to immediate removal from the school in which they are falsely enrolled. I also understand that according to T.C.A. 49-6-3003, (c) (1) (A) Any parent, guardian, or other legal custodian who enrolls an out-of-district student in a school district and fraudulently represents the address for the domicile of the student for enrollment purposes is liable for restitution to the school district for an amount equal to the local per pupil expenditure identified by the Tennessee department of education for the district in which the student is fraudulently enrolled. (2) (A) Restitution shall be cumulative for each year the child has been fraudulently enrolled in the system. Such restitution shall be payable to the school district and, when litigation is necessary to recover restitution, the parent, guardian, or other legal custodian shall be liable for costs and fees, including reasonable attorneys' fees, incurred by the school district.
